Re: Distribution of 9-1-1 Phone Taxes / Fiscal Year 2013-14 and subsequent years

Last fiscal year (2012-13) each of our member entities signed an acknowledgement agreeing to a distribution formula for allocation of 9-1-1 phone taxes. Willamette Valley Communications Center (WVCC) has received funds for the new fiscal year (2013-2014) so each member is required to sign a new acknowledgement.

The City of Newport will continue to be credited for its 9-1-1 funding for services to the Newport Police and Fire (including Newport RFPD) services and will not share funds with other agencies. Lincoln County has agreed to share a portion of its 9-1-1 funding for unincorporated areas with the remaining Fire Districts as follows:

In addition several of the Cities are also allocated funding by the state. The LinCom Board recommends (and its user agencies support) that the Cities credit their shares as follows to the respective Fire Districts that serve those cities.

As Willamette Valley Communications Center needs a signed acknowledgement from each entity to make this allocation, this instrument will serve to authorize the distribution until revoked by either the County or any individual City. The parties acknowledge that at any time the State of Oregon may change the distribution formula to invalidate this distribution methodology.
