- v City Council or its designee may impose reasonable conditions in the permit, including but not limited to: requiring an alternate date; requiring an alternate route; and restricting the size of the parade.
- v The City Council or its designed may revoke a parade permit if circumstances clearly show that the parade can no longer be conducted consistent with public safety.
