YACHATS ARTS GUILD

In 2007 many venues for crafters were available in the Yachats area while affordable venues for fine arts were not.

Nina Toepher and Georgia Beard met with the Yachats Commons Coordinator assuring her the artists in the area would support a venue for fine art.

The city put out a call to artists from Seal Rock to Ten Mile.Receiving a good response they invited the artists to set up a gallery in room 8 of the Yachats Commons. The name "Village Art Gems" was chosen.

Each weekend from November 23 to December 23 of 2007 the gallery was open and enjoyed by the community.

A group of artists met in January of 2008. After a name change (people were looking for a rock show) and directing crafters to venues more suitable for their art form, the Yachats Arts Guild was born.

Charter members Carol Summers, Georgia Beard, Nina Toepher, Kaye Gregory, Jerry Kimmel and David Baldwin formed the Steering Committee, shepherding the Guild from its earliest days. Through their hard work, determination and a lively portion of fun they have kept the Guild alive.

2009 brought many changes. Membership is now open to artists from all areas. Three members have been added to the steering committee for a total of nine. Membership has increased to 32 artists working in watercolor, oil, acrylics, pastel, colored pencil, pen and ink, photography and woodworking.

The Friends of the Commons gifted the Guild with hanging rods for the walls enabling the Guild to hang art professionally. With the support of the City of Yachats and The Friends of the Commons the Guild continues to grow.

The guild members also exhibit their work locally at Ona restaurant and Toad Hall. The guild also has had shows at the Florence Events Center, and Canyon Way in Newport.

A percentage of gallery sales helps to support the Yachats Commons.
