Title: Request for Street Name in the Dwellings Development

Item: The developer and his agent have requested that the private road inside the development be named Village Lane. Because the name was not originally shown on the plat map, the County requires City Council approval.

The normal procedure for a new street name or a change in the name would be to survey all the property owners on that street. This was not necessary in this case because the roadway lies entirely within the boundaries of the development owned by the person making the request.

The Public Works & Streets Commission voted at the July 12, 2011 to recommend that City Council approve the name requested.

Note: The original request was for Village Drive, and that is the name the Public Works & Streets Commission voted on. In checking the County Code I realized that because the road is less than 1000' feet must be either a lane or a terrace. I contacted the agent and she said to go with Village Lane.

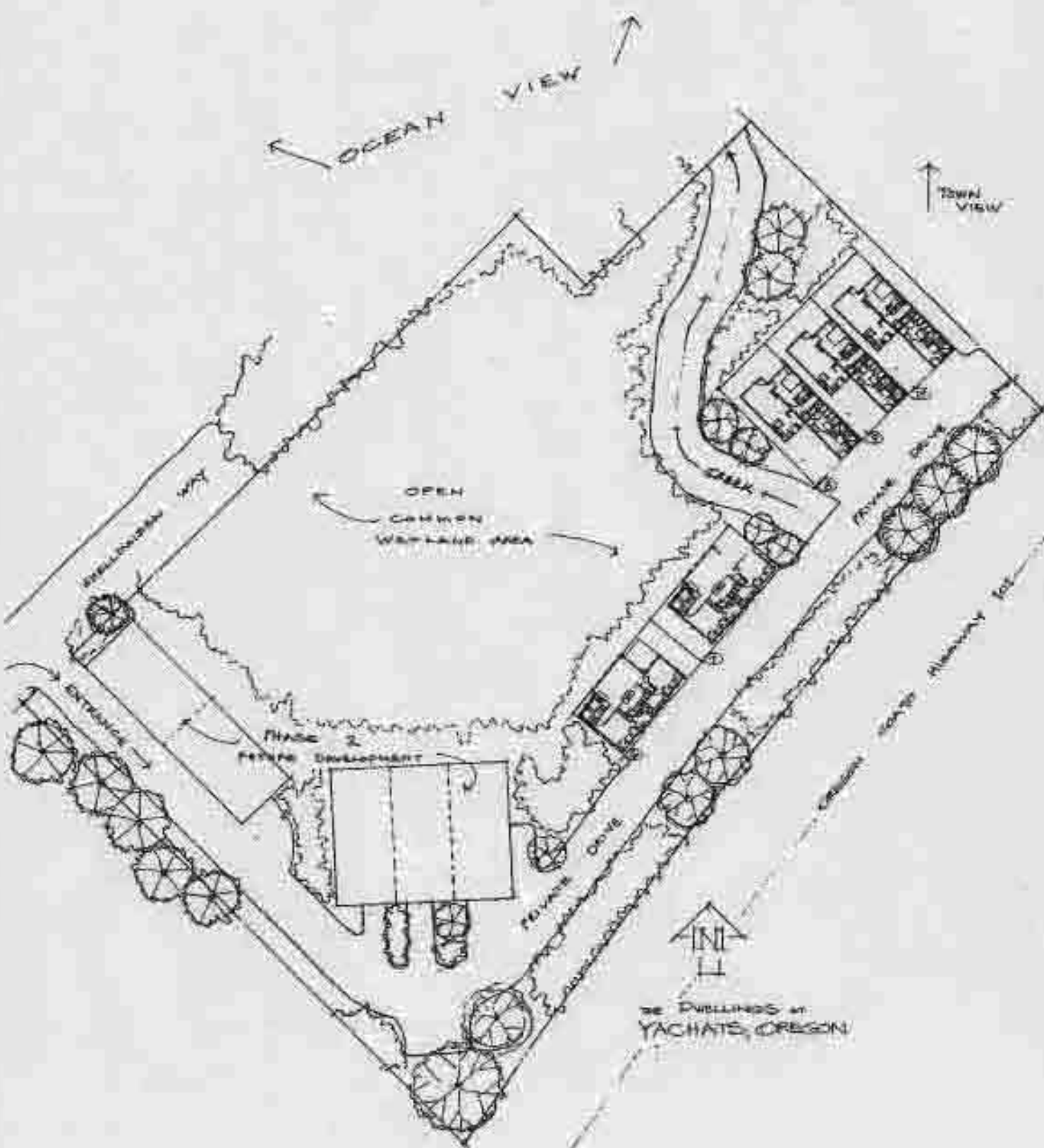
