We will monitor the beetles and move them to new plants, as we can.

- Complaint of a motor home at a Vacation Rental on Highway 101 south.
- Received an email from developer of Our Coastal Village, Aqua Vista Loop. Illegal parking on the street has been the only problem. Developer said he would talk to agent and make sure the parking restrictions are known to all residents.
