- Received call from resident on W. 3rd Street. Green truck parked for three days. Occupants sleeping in truck and noisy at night. Truck was gone when I went by.
- Several reports of loud gunshots or illegal fireworks located near King Street and cemetery.

- Talked to property owner on King Street. Escalonia hedge is blocking visibility. Owner said he would take care of it.
